Welcome	Chair Alex H declared the meeting quorate.
	Extraordinary meeting on solar farm minutes approved.
Urgent issue –	The Chair gave the context, explaining Solar Farm application leaflets had been sent
Solar Farm	out as part of the Community Council aim to encourage wider democratic
application	<ul> <li>engagement on this island, encouraging less digitally connected members of the community to participate in decisions. This was first time it had been undertaken and required digesting c300 pages in the application, as well as writing, designing, printing and (thanks to support of Millport Support Group volunteers) distributing leaflets.</li> <li>Spares held in shops.</li> <li>Gregor H gave an overview of CCC position – potentially supportive of solar power</li> </ul>
	and the carbon neutral island policy - but this application has a number of issues: size, scale of proposed panels, lack of detail, location.
	• An attendee enquired why CCC was slow in leaflet circulation. The Chair explained that the leaflet was sent out as soon as possible, CCC is made up of volunteers, some in full time employment, and more volunteers always welcomed. Gregor H noted that information was posted immediately on Facebook and on the website, and it is North Ayrshire Council's job to get out publicity about the application.
	Graham W noted NAC do not see this as a 'major application', therefore there is no need for the applicant to hold public consultation.
	<ul> <li>An attendee asked if no other more appropriate site had been considered. Gregor H stated that CCC had asked for an Environment Impact Assessment (EIA) which would have assessed why this particular site was chosen but NAC had refused on the basis of it not being a major application.</li> </ul>
	Cllr Marshall stated in 2016 the same project had applied for permission and it was noted then that the application was poor but permission was granted under certain conditions.
	Keith H noted that this project offered nothing of advantage for island residents.
	• The Chair summarised: CCC was acting democratically and seeking everyone's views.  Please respond via the leaflet or direct into the portal and give your opinion.

	<ul> <li>Chair noted she had contacted the Police to raise these problems. The problem of camping in farmer's fields and crop damage as well as at the Helipad was also raised.</li> <li>Cllr Ferguson said signage had been put up around the actual Helipad prohibiting camping but advised that there was a problem enforcing prohibition with camping in the surrounding areas. Gregor H noted there was information on <a href="https://www.cumbrae.org">www.cumbrae.org</a></li> </ul>

Cumbrae Primary	<ul> <li>The Chair reported: Cumbrae Forum have been very generous in their continued support of the school - funding swimming lessons and a day trip for the whole school.</li> <li>The school will be working with them in the redevelopment of the community garden, erection of a new polycurb and outdoor classroom. The younger children will also be visiting the church weekly to develop community relations with the forum members singing songs, rhymes and telling stories.</li> </ul>
Millport Golf Club	<ul> <li>David W reported the condition of the course has been improved with positive feedback. More bookings for next year. Camp site for Music Festival functioned well.</li> <li>Field next to course used as a car park taking pressure off parking in town.</li> </ul>
Field Studies Council	<ul> <li>Duncan F reported university visits: Newcastle 60, Southampton 98, Glasgow 35, Durham 20, Royal Holloway, London 15, and 2 groups from Germany 50. 25 from Maidstone Grammar. Large accommodation blocks used by the Bahia Religious group from London, the Mothers' Union from Glasgow, and recently the Country Music festival took the whole centre for B&amp;B last weekend.</li> <li>Still recruiting for Hospitality &amp; Catering staff.</li> </ul>
Ferry Users Group	<ul> <li>Duncan F reported on meeting of 3 August: cost of redevelopment advised as c£4.5m. Current timescale for temporary slipway Aug 2023 subject to approvals etc. Suggestion that CMAL could liaise with slipway for flood defence.</li> <li>CMAL have rejected FUG concerns and meeting organised to discuss further.</li> <li>Loch Riddon replacement was top of the priority list.</li> <li>Calmac to address contractual issues and find a suitable solution to have all crew inducted on the Catriona to allow maximum flexibility in the event of failure.</li> <li>Calmac confirmed that plans to extend seasonal staff to enable crew rotation.</li> <li>FUG raised significant concerns surrounding the lack of visibility of the community engagement plans for ticketing implementation with only 3 months to go.</li> <li>Concession tickets: Cumbrae Forum again requesting concession card holders being able to purchase multiple tickets. Calmac confirmed that SPT are willing to make changes with new ticketing system however want to see process in action on single journeys prior to approving multi journey ticketing. Calmac to provide an update.</li> </ul>
Island projects	
Data	<ul> <li>Graham W reported he had met Sarah Baird and her colleagues and discussed the Economic Baseline Report as the basis for the ten-year plan. Much more detail and breakdown on each of the datasets provided would need to be tabled before a credible action plan for the future of the island could be developed. Sarah B advised that researchers coming over to the island and gathering data might not be feasible. An island specific focus and detail was needed – not just the outline data on the areas covered in the report.</li> <li>Keith H proposed that the problem with the Baseline Report was fundamental. The data had not been derived from the island population itself; most was based on estimates from different sources at different times giving an incoherent picture. SIMD data said nothing about actual deprivation on the island. Data sets of the Scottish Office carry warnings about use in small communities like Cumbrae.</li> <li>Sarah Baird explained NAC had secured a placement with the Fraser of Allender Institute on their Economic Futures Project showing NAC's commitment to improving the quality of future data relating to the island.</li> </ul>

Ten Year Plan	<ul> <li>Declan Brennan and Lewis Monk gave a presentation on 'fresh data' in the updated 2022 report. The island's population is in decline (by 12% or 262 people). Fewer people of working age. No new data on income. Age distribution remained top heavy with large percentage 45-80 years old. 60% home occupancy (compared with 95% for North Ayrshire). House prices 46% lower on the island than NA and 17% lower than the rest of Scotland. (2021 rise not included in data). Economic output increased by £2.1 million. Decline in number of claimants since the two peaks of covid-19 in 2020. Number of vehicles with passengers leaving the island exceeded pre-covid levels. NAC stated this report gave the best picture of the island's economy that was available until census data released in 2024.</li> <li>Graham W thanked NAC for the work to date but emphasised that the key task was interpreting the necessary detailed data to inform planning and future actions.</li> <li>ClIr Ferguson asked if the data was available to elected members and the public.</li> <li>Emma McM explained that a copy of the report would be sent to CCC and there would be consultation on the different aspects of the document before it going into public circulation. If the report was found problematic from the point of view of Cumbrae residents and representatives then a further meeting could be called and the requirements of Cumbrae looked at more specifically.</li> <li>Sarah Baird reported a number of research projects were underway as part of the delivery of the ten-year plan; a group of researchers were visiting the island from an Edinburgh College who were looking at circular economies. The Carbon Neutral Programme was under way and funding has been obtained for an arts and culture development officer on the island along with Arran.</li> <li>ClIr Hill said the Locality Partnership had set up a working group as the Cumbrae</li> </ul>
	Delivery Group that would be looking that the issue of implementing the Ten-Year Plan. The Chair asked for a discussion of how the Delivery Group related to CCC. This was agreed by Cllr Hill.
Flood Defence	Gregor H noted some discussion on Facebook about benches on the front, but nothing else to report until the tender process is complete.
